

REGULAR MEETING

February 11, 2025

The Regular Meeting of the Moweaqua Village Council was called to order by Mayor Conlin leading in the Pledge to the Flag. Roll Call was answered by Kenny Long, Roger Cox, Matt Misner, Mike Snyder and Sean Hayes. Beth Hayden was absent. Employees present included Beth Hawn, Boomer Neece, Chief Hale, Brad Sams, Kyle Suydam, Mischelle Davis and Attorney for the Village, Scott Garwood was also present. Others present included Brandi, Kristy and Sawyer Shafer.

Snyder made the motion to approve the Consent Agenda with additions and corrections including the January Regular Meeting Minutes, January Special Meeting Minutes, Bills to be Paid in February and Treasurer's Report, Hayes seconded. Council voting Yes: Long, Cox, Misner, Snyder and Hayes. No: None.

Attorney Garwood presented Ordinance #2025-01 adding Chapter 113 regarding food trucks. A copy of the Ordinance was provided to Council Members for their review prior to the meeting. Attorney Garwood presented Ordinance #2025-03 amending Chapter 74 (One Way Streets and Alleys). A copy of the Ordinance was provided to Council Members for their review prior to the meeting. After discussion, Long made the motion to approve Ordinance #2025-03, Hayes seconded. Council voting Yes: Long, Cox, Misner, Snyder and Hayes. No: None.

Mayor Conlin presented a quote of \$1,688.11 for QuickBooks Checks. The Treasurer will be transitioning to the new QuickBooks program at the start of the fiscal year and the checks will be different from what has been used until now due to the new format. Snyder made the motion to approve the quote of \$1,688.11 for QuickBooks Checks.
